ORDINANCE NO. 405-05

AN ORDINANCE AMENDING REVISED CODE OF ORDINANCES
OF
CITY OF ALTAMONT, ILLINOIS
RELATING TO
WATER TAP-ON FEES

WHEREAS, pursuant to Revised Code of Ordinances, Section 38-4-10 of the City of Altamont Municipal Code, the City of Altamont, Illinois has established water tap-on fees for the use of the public water systems of the City of Altamont; and,

WHEREAS, after careful investigation, the City Council of the City of Altamont, Illinois, has determined the Illinois Plumbing Code does not provide for a 3/4" tap-on fee in average sized residential homes of today.

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTAMONT, EFFINGHAM COUNTY, ILLINOIS THAT:

Section 1. Section 38-4-10 (A) of the City of Altamont Municipal Code is hereby amended as follows:

Applicants for water service inside and outside the City limits, being commercial or residential, shall pay the following established rates, in addition to the current rate of sales tax, in advance of the tap-in connection:

1" service	\$ 750.00
1-1/2" service	\$2,000.00
2" service	\$2,500.00
