**AN ORDINANCE ESTABLISHING SCHEDULE “H”
HANDICAPPED PARKING AREAS
OF THE MOTOR VEHICLE CODE**

WHEREAS, pursuant to Section 24-6-5 of the City of Altamont Municipal Code, the City of Altamont, Illinois has established restrictions for handicapped parking.

WHEREAS, after careful consideration, the City Council of the City of Altamont, Illinois, has determined that it is necessary to provide Schedule “H” establishing the handicapped parking locations.

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTAMONT, EFFINGHAM COUNTY, ILLINOIS THAT:

Section 1: In accordance with the provisions of **Section 24-6-5**, of the Motor Vehicle Code, Schedule “H” the following handicapped parking areas are hereby established:

- (1) First parking space east of Third Street, on the north side of 100 Block of Washington Street.
- (2) First parking space south of Washington Street, on the west side of the first Block of Third Street.
- (3) First parking space on the north side and south side of the City parking lot located between 15 North Main and 23 North Main.
- (4) 1 parking space west of Second Street, on the north side of 100 Block of Jefferson Street; and one parking space near the south entrance of the Municipal Building.
- (5) 8th parking space west of Second Street on the north side of Washington Street.
- (6) 1 parking space on the north side of the pedestrian entrance and 1 parking space on the south side of the pedestrian entrance to the ball field area of Gilbert Park.
- (7) 1 parking space west of Main Street on the south side of 1st Block of Adams Street.
- (8) 2 parking spaces as indicated west of Second Street on the south side of 100 Block of Monroe Street.
- (9) 2 parking spaces east of Edwards Street on the north side of Division Street.

(10) 2 parking spaces north of Division Street on the east side of Edwards Street.
