AN ORDINANCE AMENDING REVISED CODE OF ORDINANCES
OF
CITY OF ALTAMONT, ILLINOIS
RELATING TO
PARK CLOSING HOURS

WHEREAS, pursuant to Revised Code of Ordinances, Section 31-2-15 of the City of Altamont Municipal Code, the City of Altamont, Illinois has established there are to be specific closing hours of the City Parks of the City of Altamont; and,

WHEREAS, after careful consideration, the City Council of the City of Altamont, Illinois, has determined the current Municipal Code does not establish specific closing hours.

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTAMONT, EFFINGHAM COUNTY, ILLINOIS THAT:

Section 1. Section 31-2-15 of the City of Altamont Municipal Code is hereby amended as follows:

All City Parks, including Schmidt Park, Klitzing (Heritage) Park, Triangle and Frog Pond Park will close daily at 11:00 pm. Gilbert Park reserves the exception of closing at 11:00 pm or 30 minutes after the end of the last scheduled ballgame.

No one shall be in the park without the Mayor's permission after the established hours.
